## 20/20 EXPOSES THE BETTER BUSINESS BUREAU (BBB) "MONEY-FOR-RATINGS" SCAM

On November 12, 2010, the ABC Television show 20/20 correctly exposed the Better Business Bureau (BBB) for its practice of permitting people to purchase better BBB Reliability Report Ratings. Also, 20/20 questioned the BBB's practice of giving failing grades to businesses who refuse to be "shaken down" for money to buy a better rating. Failing entities (defined as entities with a BBB Reliability Report of an "F" Rating) include the world famous Wolfgang Puck, the Ritz Carlton Hotel in Boston, Massachusetts, and, until recently, even Disneyland.

To date, Wolfgang Puck refuses to pay the BBB for the "A" Rating with the BBB. Business Recovery Services refuses to pay the BBB for the "A" rating as well.

To quote Wolfgang Puck: **"When you have to join an organization to get a good grade, I think it's wrong."**

Quoting the General Manager of the Boston Ritz carlton Hotel, Mr. Erwin Schinnerl, **"Over one million customers served and two complaints resulting in an "F" rating, seems to be somewhat unusual to say the least."**

Entities who paid for their BBB accreditation membership, such as the terrorist organization "Hamas" (actually an anonymous blogger) and a white supremacist organization website called "Stormfront" (the same anonymous blogger), received their "A-" and "A+" ratings, respectively, within 24 hours of payment.

One Los Angeles, California company called Liz's Antique Hardware even had its one
